

# MINUTES OF THE TOWN OF SMYRNA BEER BOARD

September 9, 2024

The September meeting of the Town of Smyrna Beer Board was held on Monday, September 9, 2024. The meeting was called to order by Chairperson Amy Harrison, at 5:01 p.m. at Town Hall, Smyrna, Tennessee. The pledge of allegiance was led by Chairperson Amy Harrison.

Chairperson Amy Harrison, Vice-Chairperson Jason Surratt, and Board Members Benjamin Franklin and Jennifer Brittain were present for the meeting. Board Member Michael Forrest was not present for the meeting. Staff Attorney Benjamin Groce and Town Clerk Amber Hobbs were also in attendance.

There were no citizen comments to consider.

The Board first considered a motion by Board Member Jennifer Brittain to approve the minutes of the June 3, 2024 regular meeting of the Beer Board. The motion was duly seconded by Board Member Ben Franklin and subsequently approved 4-0.

There were no old business items for the Board to consider.

The Board next considered under new business an application for a special event permit application for Beerwise Inc., dba The Casual Pint of Smyrna, to participate in the annual Depot Days celebration on Saturday, September 28, 2024. Owner, Christopher Norris, spoke concerning the application. Following discussion, Board Member, Ben Franklin, made a motion to approve the special event permit for the 2024 annual Depot Days celebration on Saturday, September 28, from 10:00a.m. to 4:00p.m. The motion was duly seconded by Vice-Chairperson Jason Surratt. Following further discussion, the motion was approved unanimously. A copy of said application is attached and incorporated herein by reference as Exhibit "1".

The Board next considered under new business an application for an off-premise permit for R&J Discount dba Discount Tobacco, Beer & Vape, 228 N Lowry Street, Smyrna. Representative, Abanoub Ghobril, spoke concerning the application. Following discussion, Board Member, Ben Franklin, made a motion to approve the off-premise permit for this location. The motion was duly seconded by Vice-Chairperson Jason Surratt. Following further discussion, the motion was approved unanimously. A copy of said document is attached and incorporated herein by reference as Exhibit "2".

There were no further new business items for the Board to consider.

Chairperson Amy Harrison stated that the next meeting will be held October 7, 2024.
