

MINUTES OF THE TOWN OF SMYRNA BEER BOARD

The June meeting of the Town of Smyrna Beer Board was held on Monday, June 2, 2025. The meeting was called to order by Chairperson Amy Harrison, at 5:01 p.m. at Town Hall, Smyrna, Tennessee. The pledge of allegiance was led by Chairperson Amy Harrison.

Chairperson Amy Harrison, Vice-Chairperson Jason Surratt and Board Members Jacqueline Redmond, Benjamin Franklin, and Jennifer Brittain were present for the meeting. Staff Attorney Benjamin Groce and Town Clerk Amber Hobbs were also in attendance.

There were no citizen comments to consider.

The Board next considered a motion by Vice-Chairperson Jason Surratt to approve the minutes of the May 5, 2025 regular meeting of the Beer Board. The motion was duly seconded by Board Member Jennifer Brittain and subsequently approved 5-0.

There were no items under old business for the Board's consideration at this time.

The Board next considered under new business an application for an off-premise permit for Sip N Smoke Shop, LLC, 13702 Old Nashville Hwy, Smyrna. Owner, Sameh Farag, spoke concerning the application. Following discussion, Vice-Chairperson Jason Surratt made a motion to approve the off-premise permit application for this location. The motion was duly seconded by Board Member Benjamin Franklin. Following further discussion, the motion was approved 5-0. A copy of said application is attached and incorporated herein by reference as Exhibit "1".

The Board next considered under new business an application for an on-premise permit for Legends Group TN, LLC, 1918 Almaville Road, Smyrna. Management Director, Chip Bradley, spoke concerning the application. Following discussion, Board Member Jennifer Brittain made a motion to approve the on-premise permit application for this location. The motion was duly seconded by Vice-Chairperson Jason Surratt. Following further discussion, the motion was approved 5-0. A copy of said application is attached and incorporated herein by reference as Exhibit "2".

The Board next considered under new business an application for an off-premise permit for Cloud Market 2, LLC, 128 N Lowry St., Unit C, Smyrna. Owner, Yoosf Habib, spoke concerning the application. Following discussion, Board Member Benjamin Franklin made a motion to approve the off-premise permit application for this location. The motion was duly seconded by Board Member Jennifer Brittain. Following further discussion, the motion was approved 5-0. A copy of said application is attached and incorporated herein by reference as Exhibit "3".

The Board next considered an additional request relative to the Special Event Permit application approved on May 5, 2025 for the Simply Smyrna Celebration event on June 14, 2025. Carpe Artista, Inc. owner, Ron Alley, spoke concerning the requested addition to the application. Following discussion, Vice-Chairperson Jason Surratt made a motion to approve the addition of the beer garden near the Depot stage, as had been done in the past, to the special event permit

during the event on June 14, 2025. The motion was duly seconded by Board Member Benjamin Franklin. Following further discussion, the motion was approved 5-0.

There were no further new business items for the Board to consider.

Chairperson Amy Harrison stated that the next meeting will be held July 7, 2025.

There being no further business to come before the Board, Vice-Chairperson Jason Surratt made a motion to adjourn the meeting. The motion was duly seconded by Board Member Jennifer Brittain. The motion was approved unanimously. The meeting was adjourned at 5:20 p.m.
